On motion of Bm. Haubert, seconded by Bm. King and by unanimous vote, the Board of Directors adopted Resolution No. 24-03 Approving a Professional Services Agreement with David L. Swing to Provide Services as Executive Director and Authorizing Its Execution.

6.2 Consider Adoption of the FY 2024/25 EBRCSA Budget

C. Boyer, Auditor, stated he would focus on the FY 24/25 budget document schedules. First was a high level summary of revenue and expenditures. Revenues are budgeted at a little over \$9 million for this year. Operating expenses budgeted at about \$4.8 million. Capital expenditures budgeted at about \$6.6 million, debt services at \$650,000. So total budgeted expenses at \$12 million. The Authority as fund balance reserves to cover the difference between revenue and expenses. In a

more detailed view of the expenditures, the current year's budgeted numbers in first column, then the projected final numbers for this fiscal year, and then based off of that information staff built the budget for next year, FY 24/25. Comparing budgeted numbers for FY 23/24 to budgeted numbers for FY 24/25. The budget is fairly consistent between years. In the current fiscal year, operating expenses are \$4.9 million, in the year coming up operation expenses will be approximately \$4.8 million. Capital expenditures are fairly consistent, that is due to certain capital costs being carried forward from last year's budget that were not used in this year's budget. The debt service is consistent at \$650,000 year-to-year until that is paid off a few years down the road. The next schedule shows the reserve balance for the Authority. By policy the Authority has to assign reserves, first being operating reserve dictates it is set at 50% of budgeted expenses for the year; for FY 24/25 they are budgeting approximately \$2,400,000 for operating reserves. The second reserve is the debt service reserve; policy stated that this is budgeted at \$1,000,000. The third reserve is the capital reserve, any remaining fund balance is put into capital reserve. Staff is forecasting the balance will be approximately \$9,000,000 and total reserves will be at \$12,000,000 at the end of FY24/25. Following that there are three more schedules. Normally, they only provide one schedule that shows the 10-year cash flow projection. This year they have three cash flow projections: the first is the 10-year cash flow projection based on what is being proposed for this year's budget, and they have also given two different scenarios so the Board can see what the cash flows look if there were changes to the fee structure. One is an annualized increase of 3% for a year going forward and the second one shows an annualized increase of 5% going forward. The top half of the schedule shows the reserve balances as well as total reserves. The first column is what is projected this year, the second column is the budgeted year, and there are several years after that which project out using assumptions of rates for the three different scenarios and then projected cost either based on contract or rate of inflation. In the middle of the page is the total reserve balance. For the budgeted year they are projecting about \$12,000,000 in reserves. Over the life of the 10-year projection if you look all the way to the right, they have about \$15,000,000 in reserves at the end of 10-year projection. If you compare that to the other two schedules, with the 3% schedule they start with \$12,000,000 at the end they would have \$25,000,000. With the 5% increase schedule, starting at \$12,000,000 and ending at \$35,000,000. This shows that if there were changes to the fee structure it would help to increase some of the reserves in the Authority's reserve balances. Keep in mind this takes into consideration that they are only budgeting for capital expenditures that they know about. There are unknown capital expenditures that could be picked up here that are not part of this analysis.

Bm. Ezell asked for clarification on the \$160,000 planning line item which was projected to not be spent.

Mr. Boyer stated that line item was budgeted for the capital improvement project and that item has been moved down to the CSI Telecommunications budget line item. It is still in the budget, it is just being reflected in a different line item this year since it was not used in the current year.

Executive Director Swing stated they would be using more than the projected \$400,000 after a recent meeting with CSI and the two radio shops. The CIP project will in full earnest in the next few months.

On motion of Bm. King, seconded by Bm. Haubert and by unanimous vote, the Board of Directors adopted Resolution No. 24-08 Adopting an Administrative Budget for Fiscal Year 2024/2025.

Bm. Covington arrived at 10:25 a.m.

6.3 Consider Adoption of Subscriber Fee Increase

Executive Director Swing stated this item reflected the Finance Committee's recommendation and then to revisit subscriber increases once that CIP or replacement project is completed. The recommended action was a subscriber increase of 3%, or \$1 per unit per month, effective July 1, 2024 and then to revisit this conversation and policy discussion around the fund balance needs on the replacement project was completed.

Executive Director Swing stated there are different rates and it depends on how an agency chose to pay. There was the \$30 subscriber fee per unit, if this recommendation is supported it would go to \$31. In addition to that there is debt service. Some agencies chose to pay that debt service payment upfront and other agencies are paying a \$15 per unit fee, until the debt service is paid off in FY 27/28 then that \$15 charge will go away.

Bm. Love asked about agencies that were in arrears. If there is a projected increase of \$252,000, is that in line with those agencies that are in arrears? They were asking agencies to pay an increase, but there were still agencies that are not current with payments. He would like to get an idea of what the amount is in arrears.

Bm. Meyer asked if there were efforts to collect any accounts in arrears.

Mr. Boyer stated the collections had been handled by the Executive Director.

Bm. Meyer stated they were at a point where they needed to find out what amounts were still due.

Mr. Boyer stated every year they send out an annual billing and if they are in arrears, they send a second bill that shows the dues that are in arrears and they can then pay that with their annual fees.

On motion of Bm. King, seconded by Bm. Haubert and by unanimous vote, the Board of Directors adopted Resolution No. 24-09 Adopting Subscriber Rate Increase.

7. <u>Committee Updates</u>:

7.1 Receive Informational Report on Recent Finance Committee Activities

The Finance Committee discussed the items that were on today's Board agenda: budget, why monies that were budgeted were not spent, and the fee increase.

7.2 Receive Informational Report on Recent Operations Committee Activities

The Operations Committee discussed the fee increase, the MOU relating to autoaid amongst agencies and other agenda items on this Board agenda.

8. Reports:

8.1 Receive Informational Report on Capital Replacement Project

Executive Director Swing is working with CSI Telecommunications as they are leading the capital replacement project. They are working with the radio shops and site visits will begin within the next couple of weeks. They will inventory the equipment that belongs to EBRCSA and what they are responsible for maintaining and replacing. The goal is to bring the capital replacement project in August for discussion.

8.2 Receive Informational Report on MPLS Project Update

There are four agencies that still need to cutover to the MPLS system. Once that happens the Active Eye Cyber Security program can be installed. The Executive Director anticipates MPLS to be completed by the end of May.

8.3 Receive Informational Report on Cyber Security Active Eye Update

There at two active eye sensors that help maintain and monitor the network. The external sensor will be activated once the MPLS project is done. Clearly, the external network is the higher priority than the internal because of external risk potential. The external sensor will be activated in the next few weeks.

8.4 Receive Informational Report on SUA Update

The SUA is underway. Meetings are happening regularly. Motorola and the Radio Shops are working on the master site first and then they will go out to dispatch centers to update the consoles and software there. Expected completion July timeframe.

8.5 Receive Informational Report on Encryption

Encryption is underway. The radio shops are starting in Alameda County with the Sheriff's Office and then moving through the rest of Alameda County.

8.6 Receive Informational Report on Walton Lane Site

This is an ongoing project. There is money set aside in the budget for this site. Staff is working with the interim Chief in Antioch. He learned today that Fire Chief Broschard is also willing to help with the project. The Executive Director's goal is to have a meeting within the next couple of weeks at the Walton Lane site to move the project forward.

8.7 Receive Informational Report on Wiedemann Project San Ramon

The Wiedemann site is on. They are dealing with some shelter issues and last-minute changes. It will provide better coverage in that area.

Executive Director Swing stated in regard to BART ISSI, it allows agencies to go underground and have radio coverage. He is meeting with stakeholders on that and that project is continuing to do some testing of radios at the current time. He is also working with BART with their similar system, different vendor, also a P-25 compliant system. Working with BART so officers can communicate directly with one another.

SUBJECT: Interoperability MOU – City of Oakland and California Highway Patrol

RECOMMENDATIONS:

Adopt a resolution authorizing the Board Chair to execute and the Executive Director to implement the proposed interoperability MOU between the City of Oakland and the California Highway Patrol.

SUMMARY/DISCUSSION:

In addition to pre-planned events, the California Highway Patrol frequently supports the Oakland Police Department with spontaneous events that occur in the City of Oakland. Some, but not all, of these events include CHP officers helping to contain side-shows, vehicle pursuits and other high-risk events. Presently, CHP officers are unable to communicate with OPD field personnel during these events, which hinders the response and safety of those involved. Both agencies have indicated their desire to share OPD talk groups (radio channels). The radio shops of each agency would facilitate radio programming and the system has the capacity to add the 135 requested radios. The Operations Committee recommended the approval of the Board of Directors to implement the attached MOU at their meeting on August 30, 2024

Radio Interoperability Agreement between the City of Oakland Police Department and the California Highway Patrol

The City of Oakland ("Grantor") and the California Highway Patrol ("Grantee") enter this Radio Interoperability Agreement ("Agreement") dated February 16, 2024, by which the City of Oakland Police Department provides to the California Highway Patrol permission to operate on the City of Oakland's Radio Frequencies, see appendix "A" on the East Bay Regional Communications System Authority ("EBRCSA") proprietary P25 radio system for the purposes and on the terms and conditions specified in this Agreement.

- 1. Term of the Agreement. This Agreement shall become effective on the date it is fully executed by all parties, and shall remain in effect, unless terminated in accordance with the terms and conditions contained in this Agreement.
- 2. Purpose. This Agreement is for the purpose of radio interoperability required in the field to allow California Highway Patrol personnel to communicate with employees of the City of Oakland Police Department with whom its personnel work on a regular and recurring basis.
- 3. Authorized Personnel. Only Grantee's personnel are authorized to use the programmed radios and transmit on the EBRCSA talk groups assigned to the City of Oakland Police Department under this Agreement. Grantee shall not allow any unauthorized personnel to utilize EBRCSA/City of Oakland Department talk groups or channels.
- 4. Authorized Use. Grantee's Authorized Personnel may use the EBRCSA/City of Oakland Police Department talk groups and channels only (1) when working with employees of the City of Oakland Police Department or during joint operations, (2) during Priority 1 circumstances as defined in the California Law Enforcement Mutual Aid Radio System Plan ("CLEMARS") system priority guidelines disaster and extreme emergency operations for mutual aid and interagency communications, and (3) during Priority 2 circumstances as defined in the CLEMARS system priority guidelines emergency or urgent operations involving imminent safety of life or protection of property. With the prior approval of EBRCSA, Grantee may also use the EBRCSA/City of Oakland Police Department talk groups and channels for training purposes on joint trainings with City of Oakland Police Department employees. The Grantee is a member of EBRCSA, therefore there will be no charge to Grantee for the access to the EBRCSA/ City of Oakland Police Department talk groups listed in Attachment "A".
- 5. Talk groups and Channels. This Agreement authorizes Grantee and its Authorized Personnel to access and transmit only on the talk groups listed in Attachment "A" as approved by the City of Oakland Police Department.
- 6. Primary Authority. The Grantee's Authorized Personnel communicating on City of Oakland Police Department channels recognize the ultimate authority of the City of Oakland Police

Department's Chain of Command while operating on the Department's designated channels, absent exigent circumstances. The City of Oakland Police Department Dispatchers shall be afforded the extent of command and control consistent with the normal operations of the Oakland Police Department. The City of Oakland Police Department shall have domain over Departmental talk groups and channels and any use of these talk groups and channels by the Grantee during preplanned operations should be coordinated prior to the start of the operation with the City of Oakland Police Department's Communications Division and designated Departmental personnel.

- 7. Radio Capabilities. Grantee must obtain its own radios capable of operation on a Motorola P25 system with the most current operating version installed in order to access talk groups on Grantor's 700MHz Interoperability System.
- 8. Radio System Maintenance and Upgrades. Grantor may perform periodic system upgrades and/or decommission parts of the radio systems. Grantor will make best effort to ensure the system is backward compatible with Grantee's radios. However, Grantor cannot and does not guarantee that the Grantee's radios will be supported through the life of this Agreement.
- 9. Radio Programming. Grantee shall submit any radios to be used under this Agreement to either the: Alameda County Radio Shop; Contra Costa County Radio Shop; Motorola Radio Shop (collectively identified as "Radio Shops"); or another Authorized EBRCSA Programming entity to program and authorize the radios to function on Grantor's EBRCSA system. Grantee shall be responsible for all maintenance and repair costs for their radios used under this Agreement.
- 10. Radio Identification Sheet. Grantee shall provide the Radio Shops or Authorized EBRCSA programming entity identified in Section 9 of this Agreement with a completed Radio Identification Sheet for each California Highway Patrol radio used under this Agreement, in order to allow Grantor the ability to properly track transmissions and radio IDs of Grantee's subscriber units and personnel accessing Grantor's network. A blank Radio Identification Sheet is attached to this Agreement as "Attachment B" and incorporated by reference as if fully set forth herein. When the personnel Grantee has assigned a programmed radio under this Agreement changes, Grantee shall provide an updated Radio Identification Sheet to the Radio Shops or Authorized EBRCSA programming entity responsible for the programming within 15 calendar days of the change, in which it shall provide updated information to the authorized personnel currently assigned to the radio.
- 11. Radio Limit. This Agreement authorizes Grantee to configure up to a maximum of <u>135</u> radios for use on the EBRCSA channels assigned to the Oakland Police Department.
- 12. Lost or Stolen Radio. In the event a radio programmed for access to the EBRCSA channels is lost or stolen, Grantee shall immediately, and in any event no later than within 24 hours, contact the EBRCSA and inform them of the six or eight digit radio numbers assigned to the lost or stolen radio for deactivation from the systems. If the radio is subsequently found,

- Grantee shall notify the Grantor and the radio may be enabled again for operations on the EBRCSA system.
- 13. Radio Identification. When the Radio Shops or authorized EBRCSA programming entity programs a radio for Grantee, they shall designate and log that radio's call sign. Grantee must ensure that its personnel identify themselves at all times on radio channels using the predetermined call sign.
- 14. Patching Prohibited. Grantee shall not permit its personnel to use frequency bridging equipment, a dispatch console or any other mechanism to "patch" or "link" any EBRCSA talk groups to any other system, channel, sub-system or any type of communications bridging equipment.
- 15. Communications Over the Radio. Grantee agrees that its personnel will use plain speech when communicating on EBRCSA/City of Oakland Police Department talk groups assigned to the City of Oakland Police Department and plain speech when using California Mutual Aid frequencies. In the event of inappropriate language or behavior, or misuse of the radio system by any of Grantee's personnel, Grantor may revoke and disallow that individual from using EBRCSA's system and channels or may terminate this Agreement and prohibit all of Grantee's radios from use within its system. If this should occur, Grantor shall notify Grantee in writing of this revocation prior to deactivation.
- 16. Disabling Radios. Grantor may disable a Grantee's radio temporarily or permanently at Grantor's sole discretion. Examples of when Grantor may determine to disable a radio include, but are not limited to: (1) if the radio is malfunctioning; (2) Grantee's personnel has been deemed by Grantor to be using the radio in violation of this Agreement; (3) Grantee allows an unauthorized usage of the radio or the EBRCSA's systems or channels; or (4) if the radio is in any way interferes with the Grantor's communications.
- 17. CLETS Transactions Prohibited. Grantee shall not run or request to be ran any CLETS transactions through Grantor. In the event Grantee requires a CLETS transaction, it will switch to its primary channel to request the transaction through its agency ORI.
- 18. Access to EBRCSA Records/NICE Recording. If Grantee seeks access to EBRCSA records/NICE recording regarding audio transmissions, it shall submit a written request to the Grantor's Custodian of Records. The request shall specify the CAD or incident number (if known), the date and location of the incident, and the name, job classification, phone number and address of the California Highway Patrol employee submitting the request. The request shall also confirm that the employee submitting the request is authorized to obtain the records sought. The California Highway Patrol agrees to treat all un-redacted material as confidential and to use any records it obtains only for official California Highway Patrol purposes in accordance with all applicable state and federal statutes.
- 19. Ongoing Associated Cost. The Grantee is responsible for any ongoing associated cost surrounding the Grantee's use of EBRCSA encryption, radio updates, hardware, software,

and any servicing of radio equipment under the Grantee's domain and control during the duration of this Agreement.

20. Notices. Unless otherwise specifically provided herein, all notices and other communications shall be in writing, addressed to the person and address set forth below and shall be (a) deposited in the U.S. mail, first class, certified with return receipt requested and with appropriate postage, (b) hand delivered or (c) sent via facsimile (only if prior written agreement has been made by the parties regarding transmission by facsimile):

From time to time any party may designate a new address or recipient for notice for purposes of this Section 20 by written notice to the other parties.

- 21. Contact Information. Each party shall provide the other party with a list of appropriate contact personnel for notices and notifications under this Agreement. Each party is responsible for updating the list to ensure it is current.
- 22. Indemnification. Each party agrees to indemnify, defend, and hold harmless the other party, its officers, agents, and employees from any and all liabilities, claims, or losses of any nature, including attorney's fees, court costs and all reasonably related legal costs, to the extent caused by, arising out of, or in connection with the indemnifying party's gross negligence or willful misconduct pursuant to this Agreement.
- 23. No Assignment or Subcontracting. Grantee may not subcontract or assign any rights, duties or obligations under this Agreement. Any agreement made in violation of this provision shall confer no rights on any party and shall be null and void.

- 24. Independent Agencies. None of the provisions of this Agreement are intended to create, and none shall be deemed or construed to create any relationship between the parties other than that of independent entities contracting with each other solely for the purpose of effecting the provisions of the Agreement. Neither party nor its employees is an employee of the other party; nor is either party or its employees entitled to any of the benefits and protections afforded to employees of the other party. The parties to this Agreement shall have no authority, express or implied, to act on behalf of any signatory in any capacity whatsoever as an agent. The parties shall have no authority, express or implied, pursuant to this Agreement to bind each other to any obligation whatsoever. The parties agree that the provisions of this Agreement are not intended to directly benefit any third party, and shall not be enforceable by any person or entity not a party to this Agreement. This Agreement is not intended to confer any legal rights or benefits on any person or entity other than the parties to this Agreement.
- 25. Proprietary or Confidential Information of EBRCSA/City of Oakland and Third Parties. Grantee understands and agrees that in accessing and using the EBRCSA/City of Oakland Police Department talk groups and channels under this Agreement, Grantee may have access to private or confidential information that may be owned or controlled by EBRCSA or the City of Oakland Police Department or to which EBRCSA or the City of Oakland Police Department has authorized access, and that such information may contain proprietary or confidential details, the disclosure of which to third parties may be damaging to EBRCSA or the City of Oakland Police Department or to third parties. Grantee agrees that all information disclosed by EBRCSA or the City of Oakland Police Department to Grantee or to which Grantee has access by virtue of this Agreement shall be held in confidence and used only in performance of the Agreement.
- 26. Modification of Agreement. This Agreement may not be modified, nor may compliance with any of its terms be waived, except by written instrument executed and approved in the same manner as this Agreement.
- 27. Termination. Either party may terminate this Agreement for any reason at any time upon 10 days written notice to the other party, or in accordance with the terms and conditions contained in Section 20 of this Agreement.
- 28. Entire Agreement. This Agreement sets forth the entire agreement between the parties, and supersedes all other oral or written provisions. The terms and conditions of the agreement may be modified only as provided for in Section 26 of this Agreement.
- 29. Severability. Should the application of any provision of this Agreement to any particular facts or circumstances be found by a court of competent jurisdiction to be invalid or unenforceable, then (a) the validity of other provisions of this Agreement shall not be affected or impaired thereby, and (b) such provision shall be enforced to the maximum extent possible so as to effect the intent of the parties and shall be reformed without further action by the parties to the extent necessary to make such provision valid and enforceable

30. Agreement Made in California: Venue. The formation, interpretation and performance of this Agreement shall be governed by the laws of the State of California. Venue for any litigation relative to the formation, interpretation and performance of this Agreement shall be in Alameda County, California. Grantee understands and agrees to waive its rights under California Code of Civil Procedure Section 395 et. al. and agrees to have any dispute pertaining to this Agreement decided in the jurisdiction of courts Alameda County.

RECOMMENDATIONS:

Approve the purchase of replacement batteries for the Highland Radio Site.

SUMMARY/DISCUSSION:

Each radio site has batteries that back-up the radio system in the event of a power failure. The batteries provide redundant power to allow for the generator to start and begin generating power until PG&E service is restored. During the recent power failure of the Highland radio site, staff learned the batteries needed replacement. The Highland radio site has two battery packs. One battery pack supports the microwave system while the other supports the radio equipment. The cost to replace the batteries is \$30,960, which exceeds the \$25,000 purchasing authority of the Executive Director. The Operations Committee recommended the approval of the Board of Directors to purchase the batteries at their meeting on August 30, 2024.

Adopt a resolution authorizing the Board Chair to execute and the Executive Director to implement the write-off of the invoices identified in the agenda report.

SUMMARY/DISCUSSION:

A review of the Accounts Receivable Aging found several invoices related to businesses that ceased operations or that should be written off due to clerical errors or at the recommendation of the Executive Director for a business relationship reason. The Executive Director recommends the Authority write off these uncollectable accounts, which requires the approval of the Board of Directors. The Finance Committee met on August 30, 2024 to review this matter and recommended the action to the Board of Directors

Additionally, the Executive Director recommends adjusting the invoice for the City of Benicia to maintain goodwill. During an audit in 2021, the external auditor found the Authority's initial billing of Benicia was not accordance with a side letter authored by the then Executive Director and signed by the City Manager of Benicia. Benicia was overbilled in one year and underbilled in others. The Authority issued another invoice on July 1, 2021 for additional Operating payments and Service payments for 2018-2022 totaling \$165,340.00 aligned with the external auditor's findings.

The City of Benicia paid their initial invoices and was never informed of the billing errors that resulted in a second round of invoicing. The omissions included an inaccurate amount charged for Operating payments and not charging for Service payments. The Executive Director seeks the authorization from the Board of Directors to write-off the additional City of Benicia Operating Payments of \$24,400 for fiscal years 2018-2022. Approving this recommendation would still require the City of Benicia to pay the previously unbilled Service Payment of \$140,940 – Invoice #CathchUp001.

Bay Medic Transport (BMT) is billed by the Alameda County Information Technology Department (ITD). BMT has three outstanding invoices from 2017-2019 totally \$17,360. A review of the records found the monies owed were paid by BMT to ITD. ITD then transferred the money to EBRCSA; however, the invoices were never updated. Invoice# 201800060, 20190105, and 20190174.

Lastly, the City of Alameda has an outstanding balance of \$61,800 from a radio count dispute. The City of Alameda provided documentation that confirms the disputed invoices and conversations with the prior Executive Director authorizing the underpayment. The Executive Director requests Board of Directors authorization to write-off of \$61,800. Invoice#20160013 and 20170005.

The total of the write-offs is \$268,854.00.

There are additional outstanding invoices that require further research. The Executive Director will return to the Finance Committee at a future meeting on additional write-off recommendations, if necessary.

SUMMARY/DISCUSSION:

The annual Audit of the Financial Statements requires an amended budget that recognizes areas where expenditures exceeded the previously appropriated amount during the budget adoption. Staff from the County Auditor's Office identified five categories that require adjustment identified in the table below. The requested amount does not reflect areas that were underspent. Total operating expenses are \$3.9 million compared to a budget of \$5.3 million.

Staff from the Auditor's Office will be present at the meeting to answer questions. This item was not presented to the Finance Committee for approval; however, the Finance Committee is aware of the budget amendment and had questions about the total expenses, the monies paid to Motorola and comparing budget v. actual expenses. Staff is presenting this item outside of the Finance Committee due to time constraints for its approval to complete the Fiscal Year 2023/2024 Audited Financial Statements and the routine nature of the item.

Each year, the Authority contracts with an independent auditor to perform a financial audit of the Authority's financial statements. The independent auditor evaluates whether the financial statements were prepared in accordance with generally accepted accounting principles. For fiscal year 2022-2023, the independent auditor expressed an opinion that the financial statements were presented in accordance with generally accepted accounting principles.

Currently, the annual audit of the financial statements is conducted by Badawi and Associates and is presented to a representative of the County Auditor's Office and the Authority's Executive Director. The financial audit was last presented to the Finance Committee in 2020. A representative of Badawi and Associates will present the 2023 report at the September Board of Directors meeting. The 2024 report will be presented to the Finance Committee in November 2024 and to the Board of Directors in December, 2024.

The proposed policy requires annual reporting and two members of the Finance Committee to serve as liaisons to the auditors for future financial statement audits. This practice will begin in

Report on the Audit of the Financial Statements

East Bay Regional Communications System Authority Management's Discussion and Analysis (Unaudited) For Fiscal Year Ended June 30, 2023

This section of the financial statements for the East Bay Regional Communications System Authority (the Authority) presents a narrative overview and analysis of the financial activities of the Authority for the fiscal year ended June 30, 2023. This information is presented in conjunction with the audited basic financial statements, which follows this section.

Financial Highlights

- The assets of the Authority exceeded its liabilities at the close of fiscal year 2023 by \$29,856,802. Of this amount, \$14,085,246 represents unrestricted net position, which may be used to meet the Authority's ongoing obligations.
- The Authority's total net position decreased by \$1,499,533 which was due to a decrease in prepaid expenses due to the timing of Motorola contract costs and a decrease in cash, offset by a decrease in unearned revenues from prior years that were recognized.
- The Authority's total outstanding long-term obligations decreased by \$2,076,764 during the current fiscal year because of principal payments. Service Payments (revenues obligated for debt payments) decreased by \$35,370, or 2.2 percent, and exceeded debt obligations by \$914,404.

Overview of the Financial Statements

The discussion and analysis are intended to serve as an introduction to the Authority's basic financial statements. The Authority reports financial statements under the enterprise fund type as it is used to report activities for which fees are charged to external users for goods and services. As such, the Authority's financial statements are prepared on an accrual basis in accordance with Generally Accepted Accounting Principles.

Enterprise Fund Financial Statements

The Authority's financial information is presented in the Statement of Net Position; the Statement of Revenues, Expenses and Changes in Net Position; and the Statement of Cash Flows. The Statement of Net Position includes all the Authority's assets and liabilities, and provides information about the nature and amounts of investments in resources (assets) and obligations to creditors (liabilities). The Statement of Revenues, Expenses, and Changes in Net Position identifies the Authority's revenues and expenses and can be used to determine whether the Authority has successfully recovered all its costs through user fees and other charges. The Statement of Cash Flows provides information on the Authority's cash receipts, cash disbursements, and net changes in cash resulting from operations, investments, and financing activities.

Notes to the Financial Statements

The notes provide additional information that is essential to a full understanding of the data provided in the financial statements.

Financial Analysis of the Authority

Statement of Net Position

The statement of net position presents information on all of the Authority's assets and liabilities, with the difference between the two reported as net position. Over time, increases or decreases in net position may serve as a useful indicator of whether the financial position of the Authority is improving or deteriorating. A summarized comparison of the Authority's assets, liabilities, and net position at June 30 is as follows:

In fiscal year 2023, total assets decreased by \$3,989,604 or 8.8 percent. This was the result of a decrease in cash of \$949,701 or 8.0 percent and a decrease in prepaid expenses due to the timing on Motorola contract costs. In addition, accounts receivable increased by \$770,118 due to outstanding member dues. The decrease in net capital assets of \$2,388,055 was due to \$4,798,251 in depreciation offset by \$1,638,433 in capital acquisition and \$893,220 in construction in progress.

Total liabilities decreased by \$2,490,071 or 17.7 percent. This was the result of a decrease in accounts payable of \$112,885, recognizing unearned revenue from prior years in the current fiscal year, and a decrease in long term liabilities of \$2,300,597. The decrease in accounts payable was due to the timing of payments made to vendors and the decrease in long term liabilities was as a result of debt payments.

Total net position decreased by \$1,499,533 or 4.8 percent. This was a result of a decrease in unrestricted net position of \$1,123,156 or 7.4 percent and a decrease of net investment in capital assets of \$376,377 or 2.3 percent. See the next section for analysis regarding the change in unrestricted net position. The decrease in net investment in capital assets is due to annual depreciation of capital assets placed in to service, net of long-term debt principal paid during the fiscal year.

As noted earlier, net position may serve over time as a useful indicator of a government's financial position. In the case of the Authority, assets exceed liabilities by \$29,856,802 as of June 30, 2023, a decrease of \$1,499,533 compared to June 30, 2022.

Statement of Revenues, Expenses and Changes in Net Position

The Statement of Revenues, Expenses and Changes in Net Position reflect how the Authority's net position changed during the recent fiscal year as compared to the prior year. These changes are reported as soon as the underlying event giving rise to the change occurs, regardless of the timing of related cash flows. A summary of the Statement of Revenues, Expenses and Changes in Net Position is as follows:

Total change in net position decreased by \$1,499,533 for the fiscal year ended June 30, 2023, because of the following:

- Total operating revenues decreased by \$1,193,924 or 13.9 percent. This was due to a decrease in operating payment revenues of \$1,110,154 or 16.1 percent and a decrease in other operating revenues of \$83,770 or 5.0 percent. The reason for the decrease in operating payments revenues in primarily due to an increase of \$1,253,012 in the allowance for doubtful accounts. Other operating revenues decrease is primarily due to fewer initial payments by new members joining the Authority.
- Total operating expenses increased by \$702,095 or 8.7 percent. The cause for the increase was primarily due to an increase in depreciation expense of \$631,589 or 15.1% and an increase in other operating expense of \$85,410, offset by a decrease in maintenance expense of \$25,468.

• Total non-operating revenues increased by \$93,060 or 88.1 percent due to higher rates on return on investment and total non-operating expenses decreased by \$478,323 due to lower financed purchase interest expense.

Capital Assets and Debt Administration

Capital Assets

The Authority's capital assets net of accumulated depreciation amount to \$27,002,756, as shown in the table below. This amount includes construction in progress, structures and improvements, machinery and equipment, and software. The increase in the Authority's capital assets of \$1,638,433 was primarily due to acquisition of encryption equipment. The decrease in the Authority's capital assets for fiscal year 2023 of \$4,919,708 was primarily due to annual depreciation.

Economic Factors and Next Year's Budget

The Authority's budget uses charges for services to recover costs associated with the operation of the communications system. The Authority charges its members various fees to have their radios connected to the system. The board of directors sets the rate structure for the Authority, which consists of three categories:

- 1. Operating Payments a \$30 monthly fee charged to members per radio connected to the system. These revenues pay for operating expenses. Any surplus is set aside to cover future maintenance costs.
- 2. Service Payments a \$15 monthly fee charged to members per radio connected to the system. These revenues pay for debt expenses. Any surplus is set aside to cover future asset replacement costs.
- 3. Initial Payments a \$200 one-time fee charged to members per radio added to the system. These revenues are set aside for future asset replacement costs.

The Authority annually updates its radio counts based on reports provided by the Information Technology Departments of the County of Alameda and the County of Contra Costa.

All of the above factors were considered in preparing the Authority's budget for fiscal year 2022-2023.

The Authority adopted its fiscal year 2023-2024 budget on June 16, 2023.

Note 1: Summary of Significant Accounting Policies

A. Scope of Financial Reporting Entity

The East Bay Regional Communications System Authority (the Authority) is a joint exercise of powers agency (JPA) organized by the State of California and composed of the County of Alameda and the County of Contra Costa created pursuant to a Joint Exercise of Power Agreement dated as of September 11, 2007. By definition, a JPA is two or more contracted public agencies jointly exercising any power common to the contracting parties, including, but not limited to, the authority to levy a fee, assessment, or tax, even though one or more of the contracting agencies may be located outside the state.

The Authority was formed to develop a P-25 compliant communications system that provides fully interoperable communications to all public agencies not only within the two counties, but with adjoining counties and State and Federal agencies as well. The development of the system was financed through multiple sources including Homeland Security grant funds from the Urban Area Security Initiative (UASI), Community Oriented Policing Services (COPS), Public Safety Interoperable Communications (PSIC), State Homeland Security Grant Programs (SHSGP), revenue bonds, and capital contributions from members.

The Authority's financial activities are reported under the JPA Radio Interoperability Fund in the County of Alameda and its funds are held by the Treasurer of the County of Alameda. The books and records for the Authority are maintained by the County of Alameda, Auditor-Controller Agency's Financial Reporting Unit.

B. Measurement Focus, Basis of Accounting, and Financial Statement Presentation

The financial statements of the Authority are presented as an enterprise fund under the broad category of funds called proprietary funds. Enterprise funds account for business-like activities that are financed primarily by user charges and use the *economic resources measurement focus* and the *accrual basis of accounting* similar to the private sector. Revenues are recorded when earned and expenses are recorded when a liability is incurred, regardless of the timing of related cash flows. Grants and similar items are recognized as revenues when all eligibility requirements imposed by the provider have been met.

The financial statements are presented in accordance with the pronouncements of the Governmental Accounting Standards Board (GASB). According to GASB Statement 34, enterprise funds may be used to report any activity for which a fee is charged to external users for goods or services.

Proprietary funds distinguish operating revenues and expenses from non-operating items. Operating revenues and expenses generally result from providing services and producing and delivering goods in connection with a proprietary fund's principal ongoing operations. The Authority also recognizes as operating revenue the portion of connection fees intended to recover the cost of connecting new customers to the system. Operating expenses include the cost of sales and services, administrative expenses, and depreciation on capital assets. All revenues and expenses not meeting this definition are reported as non-operating revenues and expenses.

C. Cash and Investments

The Authority's cash and cash equivalents are considered to be cash on hand, demand deposits, and short-term investments. The Authority maintains its cash with the County of Alameda Treasurer.

The County follows the practice of pooling cash and investments of all funds with the County Treasurer, except for certain restricted funds, which are generally held by outside custodians and classified as "Cash and investments with fiscal agents" within its financial statements.

The fair value of the Treasurer's Pool is determined on a quarterly basis. The adjustment to the cash balance of all participants in the pool is based on the cash balance at the valuation date. The change in the fair value of the investments is recognized in the year in which the change occurred. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of investments is determined using the fair value hierarchy defined by GASB Statement No. 72, Fair Value Measurement and Application.

The Treasurer's Pool is audited annually by independent auditors. In order to obtain a copy of the most recent report, contact the Office of the Alameda County Treasurer – Tax Collector at 1221 Oak Street, Room 131, Oakland, CA 94612.

D. Capital and Lease Assets

Capital assets, which include land, construction in progress, structures and improvements, machinery and equipment, software, and infrastructure, are valued at historical cost. The Authority capitalizes equipment and computer software with minimum cost of \$5,000 and \$250,000, respectively, and an estimated useful life in excess of one year. Structures and improvements and infrastructure with a value of at least \$250,000 are capitalized. Donated capital assets are recorded at acquisition value at the date of donation. Financed purchased assets, which include structures and improvements, and machinery and equipment, follow the same capitalization thresholds as capital assets.

Capital assets of the Authority are depreciated using the straight-line method applied over the estimated useful lives of the assets, using the following estimated useful lives:

Lease assets are amortized using the straight-line method over the shorter of the contract term or the useful life of the underlying asset, unless the contract contains a purchase option that the Authority has determined is reasonably certain of being exercised. In this case, the lease asset is amortized over the useful life of the underlying asset.

It is the intent of the Authority to follow the County's accounting guidelines concerning the depreciation method and estimated useful life for capital assets as closely as possible. However, the P-25 compliant communication system is itself a unique asset and is accounted for accordingly. It is estimated that the system will have a useful life of 15 years, at which time technological advances in the communications industry and a lack of replacement parts will force the system into obsolescence. The first cell of the system was operational on September 1, 2012, and any additions to the system that are capitalized will have their respective useful lives end on August 31, 2027, unless it is clear that the addition will extend the life of the system.

E. Net Position

Net Investment in Capital Assets

This category of net position groups all capital assets into one component. Accumulated depreciation and the outstanding balances of debt, excluding unexpended bond proceeds, related to the acquisition, construction, or improvement of the capital assets reduce the balance in this category. The Authority had \$15,771,556 in net investment in capital assets as of June 30, 2023.

Restricted Net Position

Restricted net position are those assets, net of their related liabilities, that have constraints placed on their use by creditors, grantors, contributors, or by enabling legislation. Accordingly, restricted assets may include unspent grant revenues, certain fees and charges and restricted tax revenues. The Authority has no restricted net position as of June 30, 2023.

F. Cash Flows

A statement of cash flows is presented for proprietary fund types. Cash and cash equivalents include all unrestricted and restricted highly liquid investments with original purchase maturities of three months or less. Pooled cash and investments in the County's Treasury represent monies in a cash management pool. Such accounts are similar in nature to demand deposits.

Note 2: Cash

As of June 30, 2023, the Authority's cash and cash equivalents were as follows:

Custodial Credit Risk – Deposits

The custodial credit risk for deposits is the risk that, in the event of the failure of a depository financial institution, the Authority will not be able to recover deposits or will not be able to recover collateral securities that are in the possession of an outside entity. The Authority's investment policy requires that deposits in banks must meet the requirements of the California Government Code. As required by California Government Code Section 53652, the market value of the pledged securities must equal at least 110 percent of the Authority's deposits, with the exception of mortgage-backed securities, which must equal at least 150 percent.

County of Alameda Treasurer's Investments

The Authority is considered a voluntary participant in an external investment pool as the Authority deposits all receipts and collections, except those required to be deposited with the trustee, with the County of Alameda Treasurer.

Funds with the County Treasurer are invested pursuant to the annual investment policy established by the Treasurer and approved by the Board of Supervisors. The objectives of the policy are, in order of priority: preservation of capital, liquidity, and yield.

The policy addresses the soundness of financial institutions in which the County deposits funds, the types of investment instruments and the percentage of the portfolio, which may be invested in certain instruments, as permitted by Section 53600 et seq. of the Government Code of the State of California. Authorized instruments in which the Treasurer can invest include U.S. Treasury securities, banker's acceptances, federal, state and local government securities, commercial paper, medium-term corporate notes, negotiable certificates of deposit, local agency investment fund, California asset management program, and money market mutual funds.

Interest Rate Risk

Interest rate risk is the risk that changes in interest rate will affect the fair value of an investment. In accordance with the investment policy, the County Treasurer manages the risk exposure by limiting the weighted average maturity of its investment portfolio to not more than two years at any time. The weighted average maturity of the County Treasurer's pool at June 30, 2023 was 473 days.

Note 3: Capital and Lease Assets

The Authority began constructing the Project 25 compliant communications system in fiscal year 2008 with the goal of developing a communications system that would allow public agencies within the counties of Alameda and Contra Costa to communicate with one another. The system consists of six cells with a total 34 sites, and provides fully interoperable communications to all public agencies within the two counties. The system is also designed to offer participation to adjoining counties, as well as State and Federal agencies. As of June 30, 2013, construction of the system was complete and the system was fully operational.

The Authority financed the acquisition of equipment and recorded the equipment as capital assets with corresponding financed purchased obligation liabilities. The Authority also leased the right to use cell towers on third-party property to transmit its signals. Since these cell tower leases are granting the Authority access to a portion of the useful lives of the assets, the Authority recorded lease assets with corresponding lease liability.

Note 4: Long-Term Obligations

On April 21, 2011, the Authority issued a total of \$6,136,866 in 2011 Series A & B revenue bonds for the acquisition of the communications system in the amount of \$3,681,752 and \$2,455,114, which were acquired by Alameda County and Contra Costa County respectively. The bonds have a fixed interest rate of 4.05 percent. The bonds are payable from and secured by 100 percent of the revenues collected from Service Payments paid by its members for operating the Authority's communications system. The total debt service (principal and interest) on the Series A & B revenue bonds for the year ended June 30, 2023 amounted to \$647,006 compared to pledged revenues earned of \$1,561,410.

On June 1, 2014, the bonds converted from Capital Appreciation Bonds to Current Interest bonds. The accreted interest amount of \$325,248 for the Series A and \$216,886 for the Series B was applied to the principal balance of the loans.

Note 5: Risk Management

The Authority is exposed to various risks of loss related to torts: theft of, damage to, and destruction of assets, errors and omissions, injuries to employees, and natural disasters. The Authority participates in the Special District Risk Management Authority's (SDRMA) property and liability insurance program for risk of loss. The program provides for coverage for bodily injury, property damage, pollution, public official and employee errors, personal liability for board members, employment practices liability, employee benefits liability, employee dishonesty coverage, auto bodily injury, auto property damage, uninsured/underinsured motorists, property coverage, and boiler and machinery coverage. Members are also the users of the Authority's communications system and pay all operating revenues associated with the Authority's operations, which totaled \$7,383,708 for the year ended June 30, 2023. In addition, the Authority uses the County of Alameda Treasurer's Pool for investment management as disclosed in Note 2 above.

The Authority bills members monthly operating and service payments for access to and use of the communications system. The County of Alameda Treasurer's Pool posts interest income at the end of each quarter with interest credited to the Authority subsequent to each quarter-end.

SUBJECT: Accounts Receivable and Annual Bill for Services Policies

RECOMMENDATIONS:

Adopt a resolution authorizing the Board Chair to execute and the Executive Director to implement an Accounts Receivable policy and updated Annual Bill for Services policy.

SUMMARY/DISCUSSION:

During the Executive Director transition process, it was found that member agencies owed the Authority money for past due subscriber fees. The monies owed are due to a combination of factors that are more easily distilled to a lack of an appropriate policy for oversight of receivables. The Authority's fund balance presented during the budget presentation at the May 3, 2024 meeting does not reflect the amounts owed – meaning that fund balance has and will increase as monies are paid, providing for more money to be allocated to Capital Infrastructure Replacement, and thereby lowering future rate increases.

In order to bring accounts to current status the Executive Director will meet with the County Auditors Office to review past due accounts. The Executive Director has made a recommendation to the Board for write-offs of some balances and implemented a plan for payment of others. To prevent the existing situation from reoccurring, the Executive Director recommends the development of an accounts receivable (A/R) policy that includes the following three components:

- 1. Use of monetary penalties and collection practices to encourage timely payment.
- 2. Annual reporting of past due accounts to the Finance Committee.
- 3. Authorizing the Executive Director to recommend write-off of certain debts with Board approval.

<u>Use of Monetary Sanctions:</u> Existing policy allows for a 10% penalty for bills not paid by September 1. The Executive Director recommends enforcing this policy and adding that the subscriber is responsible for any legal or collection fees associated to the collection of past due monies. Since the Authority has limited Staff people, the Director should have the authority to use outside resources to assist in the collection of past due accounts and those charges should be borne by the past due account holder.

Annual Reporting: It is widely known that the COVID-19 pandemic disrupted the ecosystem of life world-wide in 2020 and subsequent years. EBRCSA was not immune from those impacts. It is documented in the Finance Committee minutes that the Committee requested an update on the A/R Aging. Unfortunately, that information was not presented to the Committee resulting in a lack of awareness. Codifying in policy the requirement for an annual update on the A/R Aging will better ensure the information is presented so that the Board is aware of any issues.

<u>Debt Write-Off:</u> During the investigation of the A/R Aging, Staff learned that some of the debts are uncollectable or should be forgiven based on documentation provided by the end user. The policy recommends the Executive Director have the authority to write-off the debt in limited situations and report back to the Board of Directors in those instances while the Board of Directors retains authority for more significant amounts or situations that are outside of the norm.

In closing, while a high A/R aging balance demonstrates a need for stronger oversight, the payment of monies owed will help off-set future rate increases as the fund balance and interest earnings increase. The development of and adherence to the proposed policy will mitigate the risk of this situation reoccurring in the future. The Executive Director is seeking the approval of the Board of Directors for the proposed Accounts Receivable policy as recommended by the Finance Committee on August 30, 2024.

The changes to the Annual Bill for Services policy are non-substantive and consist of changing "Clerk" to "Designee" for the mailing of invoices to align with the new Accounts Receivable policy and other minor word choice changes.

PURPOSE

To establish a policy for annual billing of the services provided by East Bay Regional Communications System Authority ("EBRCSA").

POLICY

The EBRCSA shall ensure that invoices are paid in a timely manner through the proactive collection of monies owed for services provided.

PROCEDURE

Payment of invoices

- 1) The Authority will bill each member agency for its respective operating and debt payment by July 1 of each year.
 - The bill will be issued to the attention of each member agency's executive or designee;
 - Fees are due and payable on receipt with a two-month grace period;
 - All unpaid accounts as of September 1, of the year which the bill was issued, will be billed a 10 (ten) percent late fee.
 - Delinquent accounts will be referred to collections six months after the date of issuance of the invoice.
 - Members are responsible for the payment of fees associated with using additional resources. Examples include, but are not limited to, fees and costs for legal or collection services.
- 2) The Executive Director will present the Accounts Receivable Aging to the Finance Committee prior to the December Board of Directors meeting to review the number of and value of accounts with outstanding balances.
- 3) The Executive Director shall have the authority to write-off uncollectable accounts and report to the Board of Directors at the December meeting in the following situations:
 - The member is a private business that ceased operation prior to paying the invoice;
 - The amount owed is due to a radio count dispute and a partial payment was made;
 - The amount owed is due to a billing error;
 - The amount owned is \$25,000 or 50% of the invoiced amount, whichever is less.

To establish a policy for annual billing of the services provided by East Bay Regional Communications System Authority ("EBRCSA").

POLICY

The EBRCSA shall make claim annually for the cost of operating the system based on the number of mobile and portable radios.

PROCEDURE

Billing for Annual Operating and Debt Payments

- 1) Members are responsible for ensuring that the EBRCSA Executive Director is aware of any radios added or deleted from the system.
 - The Executive Director will utilize biannual reports that will determine if the number of mobile and portable radios each agency is operating on the system has increased;
 - The Auditor will be provided the information which will be used in the preparation of the annual bill
- 2) The Authority will bill each member agency for its respective operating and debt payment by July 1 of each year.
 - The bill will be issued to the attention of each member agency's clerk designee;
 - Members will have 30 days from the receipt of the bill to challenge the bill as to the number of mobiles or portables which they are being billed for;
 - Fees are due and payable on receipt with a two-month grace period;
 - All unpaid accounts as of September 1, of the year which the bill was issued, will be billed a 10 (ten) percent late fee.

SUBJECT: Subscriber Memorandum of Understanding (MOU)

RECOMMENDATIONS:

Adopt a resolution approving and authorizing the Executive Director to execute as necessary and implement a Subscriber MOU and fee schedule that complements the Operating Agreement.

SUMMARY/DISCUSSION:

During a review of the operations of the Authority and in consultation with Authority Counsel, staff learned that a need exists for a separate Subscriber MOU for entities that are joining the system as users yet do not need the complexities of the full Operating Agreement. Additionally, the current Operating Agreement and fee structure for new users requires payment of a \$200 per radio start-up fee and the combination of the monthly operating and service fees totaling \$46 per radio until the bond is paid off in 2027. The \$15 service fee pays for the bonds that provided the capital for the initial system build. The proposed Subscriber MOU does not require the payment of the \$15 per unit Service Payment since the users are low volume and future operating payments will provide for future replacement once the long-term infrastructure replacement costs are known.

The Operations and Finance Committees recommend the proposed Subscriber MOU to the Board for approval at its meetings on August 30, 2024.

MEMORANDUM OF UNDERSTANDING BETWEEN EAST BAY REGIONAL COMMUNICATIONS SYSTEMS AUTHORITY AND FOR SUBSCRIPTION ACCESS TO AUTHORITY INFRASTRUCTURE
This Memorandum of Understanding ("MOU") is effective as of the date of the second signature below and is entered into by and between East Bay Regional Communications Systems Authority ("EBRCSA" or "Authority") and (""), collectively referred to as the "Parties".
A. Scope of Services and Initial Term The scope of services provided under this MOU involve Authority providing a subscription to use and access Authority communications infrastructure for a fee. The geographic scope of services shall be within Authority's jurisdictional limits as defined by Authority's joint powers agreement. The Initial Term of this MOU shall be twelve (12) months commencing from the effective date, with an automatic twelve-month renewal unless terminated in accordance with this MOU. Details of the services provided by Authority are limited to the following:
Service: Access and use of Authority infrastructure for emergency communications needs or requirements.
B. <u>Communication</u> Designated staff from both Parties shall communicate on the needs and expectations of each Party as they arise or on an "as needed" basis.
 Dispatch: shall provide and use its own dispatch services; Authority itself has no dispatch service.

C. <u>Payment and Invoicing</u>
Payments will be made based on actual equipment delivery and any services rendered.
Payments are due thirty (30) days from the date of invoice. Authority shall issue invoices as frequently as it deems necessary, but no less than once a year. The fees below may be adjusted at Authority's discretion and become effective upon 30 days' advance written notice.

One time start up fee	\$200.00
Monthly fee (per unit)	\$31.00
Fee for late payment	10% after date of invoice
Fee to activate replacement unit	\$200.00

D. General Terms and Conditions

1. Indemnity and Insurance

Each Party represents that it is self-insured and has insurance coverage of sufficient breadth and coverage for the scope of services contemplated herein. Each Party shall procure, hold current during the Term of this MOU, and upon request provide evidence of commercial general liability insurance of at least \$1,000,000, workers compensation insurance commensurate with statutory requirements, automobile liability insurance for all owned, hired, and non-owned vehicles of at least \$1,000,000 and proof that each Party is added as an additional insured on the other Party's insurance policies. ______ shall require and upon request show proof that its subcontractors or subconsultants performing any or all the scope of services under this MOU, if any, have procured, hold current, and will produce upon request evidence of insurance coverage and at the amounts described herein.

2. Early Termination

Either party may terminate this MOU for any reason upon thirty (30) days written notice to the other party, it being understood that the respective rights and obligations of the Parties shall continue to be governed by this MOU until the effective date of such termination.

If either Party finds the other Party is acting fraudulently, or engages in willful misconduct, gross negligence, or bad faith, it may terminate this MOU immediately upon notice to the other Party.

3. Amendment

Either party may request a modification to this MOU by doing so in writing. All changes, other than the Early Termination provisions above, must be agreed to by both parties in writing, via an executed amendment.

4. Independent Contractors The Parties agree that they are independent contractors, and not partners, or joint venturers in the provision of services under this MOU. No employee or agent of either Party shall qualify for or be considered an employee of the other Party or qualified to collect insurance or retirement benefits from the other Party. Authority is not and shall not be considered by a joint or co-employer of any employees, subcontractors or subconsultants shall indemnify and hold harmless Authority from all claims, causes of actions, injuries or damages related to joint employment or co-employer status.
