- 3. Approval of Minutes of August 30, 2024, Operations Committee

4. Purchase of Replacement Batteries for Kregor Radio Site

On motion of Bm. King, seconded by Bm. Beltran, and by unanimous vote, the Operations Committee approved recommending the Board of Directors to purchase replacement batteries for the Kregor Radio Site.

5. East Bay Regional Communications System Authority Updates

Executive Director Swing provided a brief update on the following items.

- Change of Generator Service Company New contractor, Bay City Electric Works, will begin servicing generators in December 2024.
- Radio Purchase Agreement The purchase agreement is pending approval by the Contra Costa County Board of Supervisors. The terms of the agreement includes a minimum purchase of 1,400 radios per year with any surplus purchases of over 1,400 to be credited to the account for the following year. The radio pricing under the agreement is exclusive to EBRCSA and the agreement cannot be shared by other agencies.
- The City of Antioch Site on Walton Lane No status change.
- Tracy Police Department Interest EBRCSA's radio signal strength is strong enough to cover the area except for Tracy hills and would require an upgraded signal strength. Further conversations are required with Motorola.
